ARTICLES OF INCORPORATION

We, the undersigned, do hereby associate ourselves together and subscribe these Articles of Incorporation for the purpose of forming corporation under the laws of the State of Florida, Chapter 607 and subject to the following provisions:

ARTICLE ONE

The name of the Corporation shall be:

TOTOS SERVICES, INC.

ARTICLE TWO

This corporation shall have perpenal existence and may engage to any activity or business permitted under the laws of the United States and of the State of Florida.
