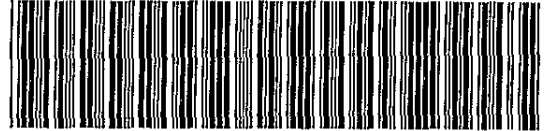

**ARTICLES OF INCORPORATION OF
LAWLOR ENTERPRISES, INC.**

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE ONE: NAME

The name of this corporation is Lawlor Enterprises, Inc. (hereinafter referred to as the "Corporation").

ARTICLE TWO: DEFINITIONS

1. The principle place of business is 6554 Pelican Avenue, Coconut Creek, Florida 33073.
2. "Corporation" as used herein shall mean the corporation for profit, the corporation formed by these Articles, its successors or assigns.

ARTICLE THREE: PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To engage in the business of owning and operating Laundromats.
2. To engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

ARTICLE FOUR: CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is Five Thousand (5,000). Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share.

ARTICLE FIVE: OFFICERS AND DIRECTORS

The number of directors constituting the initial board of directors of the corporation is two. The officers of the Corporation shall be a President, a Vice President, a Secretary, and a Treasurer. Any two or more offices may be held by the same person. The name and address of each person who is to serve as an Officer or Director is as follows:

ARTICLE SEVEN: BYLAWS

The Board of Directors shall, from time to time, adopt, alter, amend, or rescind Bylaws not inconsistent with these Articles. However, the provisions of these Articles shall prevail in any conflict between the provisions of these Articles and the provisions of the Bylaws.

ARTICLE EIGHT: DESIGNATION OF REGISTERED AGENT

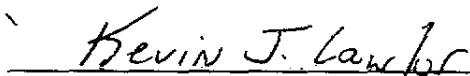

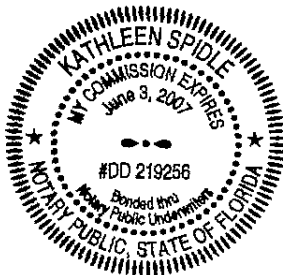
