ARTICLES OF INCORPORATION OF

LAWLOR ENTERPRISES, INC.

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE ONE: NAME

The name of this corporation is Lawlor Enterprises, Inc. (hereinafter referred to as the "Corporation").

ARTICLE TWO: DEFINITIONS

- 1. The principle place of business is 6554 Pelican Avenue, Coconut Creek, Florida 33073.
- 2. "Corporation" as used herein shall mean the corporation for profit, the corporation formed by these Articles, its successors or assigns.

ARTICLE THREE: PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:
