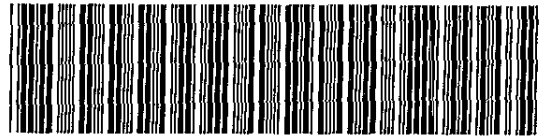

The board of directors may from time to time move the principal office to any other address in Florida.


ARTICLE VII, INITIAL BOARD OF DIRECTORS
