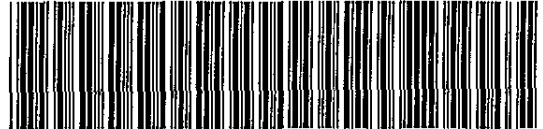

***ATTACHMENT TO ARTICLES OF INCORPORATION
FOR MCNEILL ELECTRIC & COMMUNICATIONS, INC.***

ARTICLE III PURPOSE

TO ENGAGE IN THE CONSTRUCTION, REPAIR, AND REMODELING OF BUILDINGS AND PUBLIC WORKS OF ALL KINDS, AND THE DOING OF ANY OTHER BUSINESS AND CONTRACTING WORK TO INCLUDE INSTALLATION, MAINTENANCE, AND REPAIR OF ELECTRICAL AND COMMUNICATION SYSTEMS.
