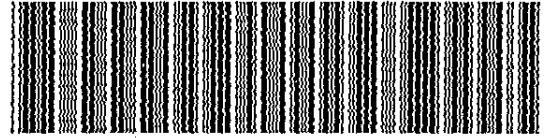

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is: INTERNET AUTO SOLUTIONS, INC.

ARTICLE II - NATURE OF BUSINESS

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE XI – INITIAL REGISTERED AGENT

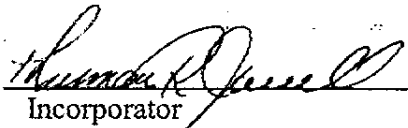
