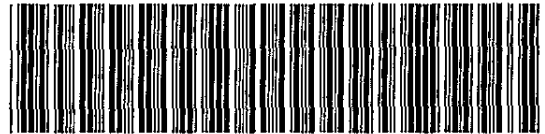

ARTICLE V - STOCK

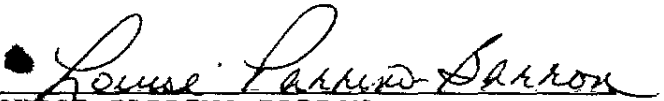
The aggregate number of shares which the corporation is authorized to issue is 100 shares. Such shares shall be of a single class and have a par value of \$5.00 per share.

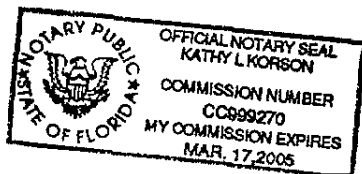
