ARTICLES OF INCORPORATION

RIVERFRONT HAIR STUDIO, INC.

Secretary Secretary The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

<u>ARTICLE I ~ NAME</u>

The name of the corporation shall be RIVERFRONT HAIR STUDIO, INC.

<u>ARTICLE II ~ PRINCIPAL OFFICE</u>
