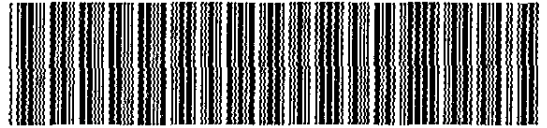

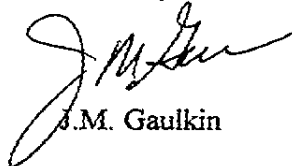

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

C.S. AUTO BODY REPAIR, INC.

The address of the principal office of this corporation shall be 8040 S.W. 69TH Avenue, Miami, Florida 33143 and the mailing address shall be the same.

ARTICLE II. NATURE OF BUSINESS

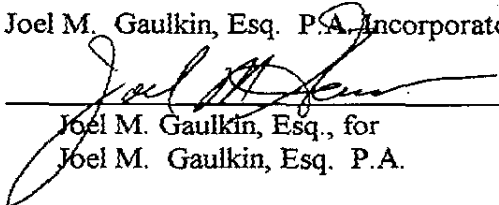
