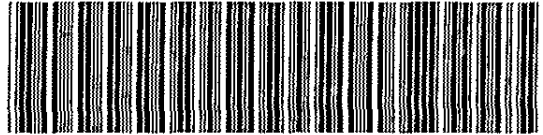



**ARTICLES OF INCORPORATION
OF

I, the undersigned, hereby organize for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida and liabilities of Corporations for profit.

ARTICLE I – NAME

The name of the Corporation shall be:

GILLILAND BUILDERS, INC.

ARTICLE II – DURATION

This Corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III – PURPOSE

The Corporation may engage in any activity or business under the laws of the United States and the State of Florida's General Corporation Act.

ARTICLE IV – CAPITAL STOCK

This Corporation is authorized to issue 1,000 shares of \$1.00 par value common stock, which should be designated "Common Stock."

ARTICLE V – CAPITAL

The amount of capital with which the Corporation will begin business shall be \$100.00.

ARTICLE VI – INITIAL REGISTERED OFFICE AND AGENT

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and Shareholders.

Shares held by the initial shareholders listed above may not be resold or otherwise transferred to other persons unless such shares are first offered to the remaining shareholders or to this Corporation. The price and terms at which, and the time within which, such shares may be offered and sold shall be further specified by written agreement among all of the shareholders and this Corporation.

ARTICLES XII – ADOPTION OF BYLAWS

A special meeting of the subscribers or their assigns shall be held, upon the call of the president, for the purpose of completing the organization of the Corporation and the adoption of the bylaws and the transaction of such other business as may come before the meeting.



ARTICLE XIII – AMENDMENT

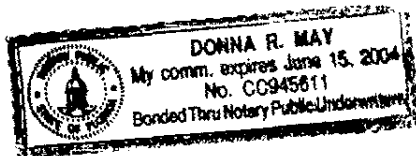
