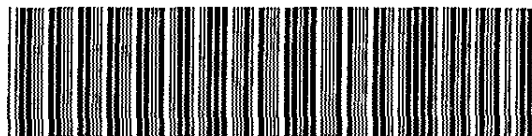

NAME

The name of the corporation is ACH Custom Home Builders, Inc.
