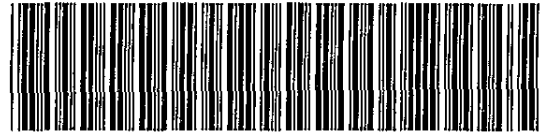

CERTIFICATE OF INCORPORATION

OF






