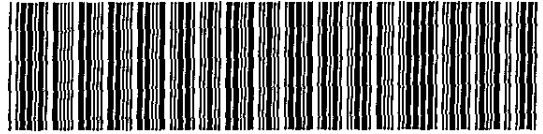

ARTICLE XI - AMENDMENT

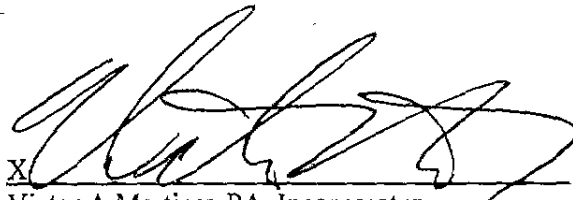

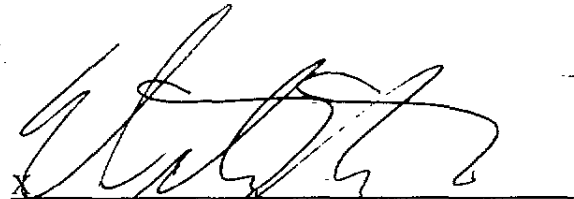

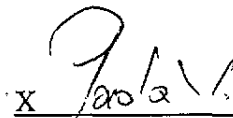
