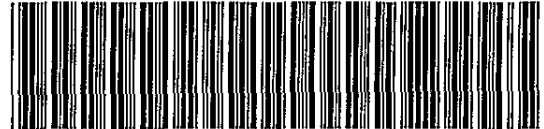

ARTICLE I

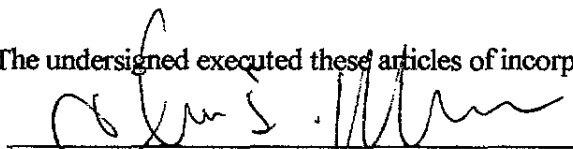

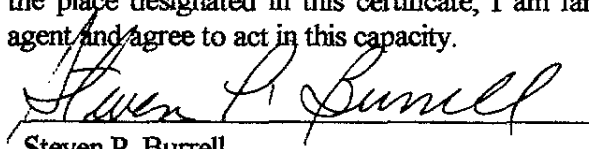
