Dear Ms. Milligan:

I called the telephone number (850-245-6059) upon receipt of your October 25, 2004 letter to clarify the status of my lawn service/janitorial corporation, as I was unsure of how to proceed if I wished to question the imposition of extra fees for the 2004 or any other year.

I spoke to Ruby of your office on Friday, November 12, and explained that I was unaware of any requirement to file a 2004 corporate annual report form when I sent my renewal check of \$150 (# 1797 dtd, 10-10-04) to accompany my request for renewing my corporation certificate. She was very helpful to me and explained that I needed to send a letter stating the following in order to have the status changed from "dissolved" to being active again. So I asked a friend to help me structure this letter appropriately, and I also now understand the requirement for an "annual report," which accompanies this letter along with the Corporation Reinstatement Form from the Department of State. I apologize for my previous lack of understanding. Ruby also instructed me to include in this letter the statement herein that I "had not received a letter asking for a 2004 filing of an annual report from the Department of State," and this would suffice to alleviate the penalty fees for a reinstatement process. Please advise me if these items are not sufficient and I will provide whatever else is needed.

I am therefore re-sending my check for my corporation renewal in the amount of \$150 with the annual report and hope this will satisfactorily clear up my corporate reinstatement. If there are other fees that would not be considered in the "penalty" category, I will be happy to forward them as well. I thank you for any consideration that can be given in this matter, as my business is quite small and the fees would be a heavy expense to me.

Please understand I am not from the United States, but from Jamaica, and just simply was not aware of the requirement for an annual report, particularly since I did not receive instructions to that effect from your or the appropriate state office. I will be certain to comply with any future requirements now that I am aware of them, and certainly hope appropriate instructions reach me in the future.

Thank you again for your department's acceptance of my explanation, hoping I have followed Ruby's instructions correctly, and my corporation may be reinstated without further penalty.
