**ARTICLE I - NAME**

The name of this corporation is ALLENSONS, INCORPORATED

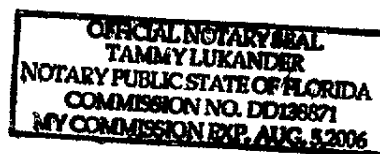
