<u>ARTICLE 1. - NAME</u>

The name of the Corporation is Cirranello Woodworks, Inc..

ARTICLE 2. - PRINCIPAL OFFICE

The principal office of the Corporation shall initially be at 1728 8th Avenue Drive West, Bradenton, Florida 34205. The Corporation may change its principal office from time to time as permitted by law.

ARTICLE 3. - MAILING ADDRESS
