The name of this corporation is FLOOR DEPOT, INC. and the mailing address of the corporation shall be 12541 Metro Parkway, Unit #10, Fort Myers, FL 33912.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

ARTICLE THREE

The duration of the corporation is perpetual.

ARTICLE FOUR

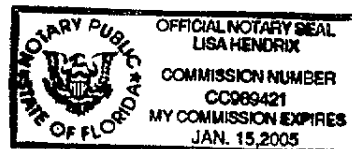

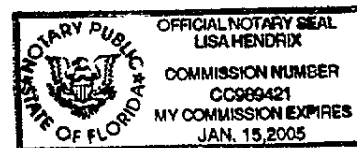
