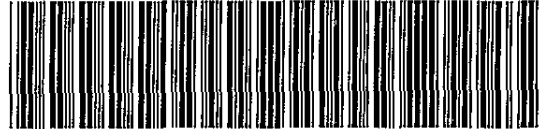



ARTICLE I. NAME
