The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

INVEST LOCALLY, INC.

The address of the principal office of this corporation shall be 725 N. A1A, Suite C-203, Jupiter, Florida 33477 and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities of business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having no par value per share. Each common share shall entitle the holder thereof to one vote. No holder of the common shares shall be entitled to any right of cumulative voting.

The Board of Directors shall have the right and authority to amend this Article III and put forth different classes of stock and

rights and limitations of each such class without the necessity of shareholder approval.

ARTICLE VII - DIRECTOR AND OFFICER INDEMNIFICATION


