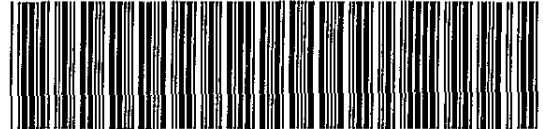

ARTICLE I - NAME

The name of this Corporation is Ledesma-Cravey Publishing, Inc.

ARTICLE II - ADDRESS

The principal place of business and the mailing address of the Corporation is 12228 Breckenridge Court, Jacksonville, FL 32223.

ARTICLE III – PURPOSE of PROFESSIONAL CORPORATION

This Corporation, Ledesma-Cravey Publishing, Inc., is organized to publish and produce community-based magazines in Northeast Florida. This Corporation is also organized to publish quality editorial content, as well as sell advertising in said community-based magazines.

ARTICLE IV – NUMBER OF SHARES OF STOCK

(a) Authorized Shares. This Corporation is authorized to issue 5,000 shares of common stock, all of which shall be of the par value of \$.01 per share. Each of the shares of common stock shall entitle the holder thereof to one (1) vote at any meeting of the shareholders. All or any part of the common stock may be paid for at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be fully paid and nonassessable.

(b) Preemptive Rights. Shareholders shall have no preemptive rights.

(c) Cumulative Voting. Cumulative voting shall not be permitted.

(d) Restrictions on Transfer of Stock. The shareholders may, by bylaw provision or by shareholders' agreement recorded in the minute book, impose such restrictions on the sale, transfer, or encumbrance of the stock of this Corporation as they may see fit.

ARTICLE V – DIRECTORS

(a) Number. The Corporation shall initially have two (2) directors. The number of directors may be changed from time to time in accordance with the bylaws of this Corporation.

(b) Compensation. The Board of Directors are hereby specifically authorized to make provision for reasonable compensation to its members for their services as directors, and to fix the basis and conditions upon which such compensation shall be paid. Any director of the Corporation may also serve the Corporation in any other capacity and receive compensation therefor in any form.

(c) Indemnification. The Board of Directors is hereby specifically authorized to make provision for indemnification of directors, officers, employees and agents to the full extent permitted by law.

IN WITNESS WHEREOF, the undersigned incorporator has executed these Articles of Incorporation this 11th day of July, 2003.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT
