Articles of Incorporation

A Florida Corporation

The undersigned incorporator to these Articles of Incorporation hereby associates to form a corporation (the "Corporation") under Chapter 607 of the Florida Statutes.

1. Name

The name of the Corporation is Flash Forward, Inc. The Corporation's principal office is located at 2717 Santa Barbara Boulevard, Cape Coral, Florida 33914 and mailing address is 3749 SW First Place, Cape Coral, Florida 33914 in Lee County, Florida. The Board of Directors may from time to time move the principal office of the Corporation to any other address in the State of Florida.

2. <u>Nature of Business</u>
