ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION  
OF  
WHITCO CLEANERS, INC.

Whitco Cleaners, Inc., a Florida corporation (the "Corporation"), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

ARTICLE I

The name of the corporation shall be Whitco Cleaners SOHO, Inc.

2. The foregoing amendment shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the corporation laws of the State of Florida.
