

ARTICLES OF INCORPORATION

OF

DESIGN CONCEPT MARKETING, INC.

ARTICLE I

The name of this corporation shall be DESIGN CONCEPT MARKETING, INC.

ARTICLE II

PRINCIPAL OFFICE

The principal office of this corporation shall be at:

ARTICLE III

DURATION

The corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE IV

PURPOSE

This corporation is organized for the following purposes:
