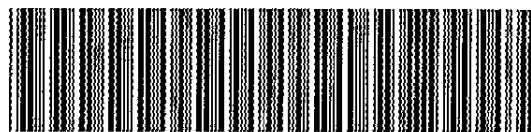


OTHER PROVISIONS:
