We, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the state of Florida.

Upon the sale for cash of any new stock of the same kind, class of series as that which he already holds, every stockholder of this corporation shall have the preemptive right to purchase his pro-rate share thereof at the price at which it is offered to others, whether or not in excess of par.
