ARTICLES OF INCORPORATION OF: LIBRA & GEMINI, INC.

GEMINI

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statues.

ARTICLE I - NAME
