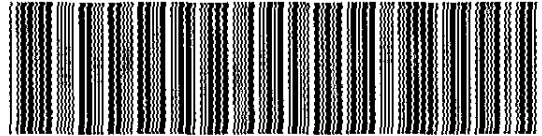

Article One
Name




