The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I Name and Principal Office of Corporation

The name of this Corporation shall be CORDERO-MOLYNEUX FINE ARTS, INC. The initial mailing address of the Corporation shall be 10175 Collins Avenue, No. 406, Bal Harbour, Florida 33154.

ARTICLE II Purpose and Nature of Business
