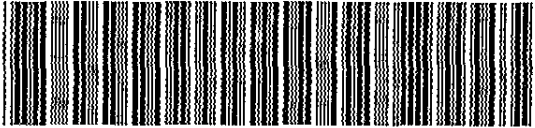



**I. NAME AND MAILING ADDRESS**
