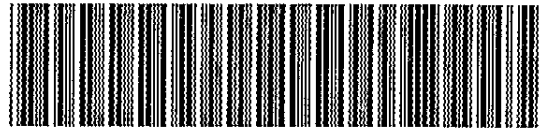

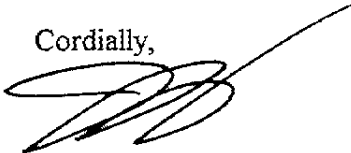

ARTICLE I

The name of this corporation is The Hobby Superstore.com Inc.

ARTICLE II

The purpose or purposes for which this corporation is organized is for the purpose of transacting any and all lawful business.

ARTICLE III

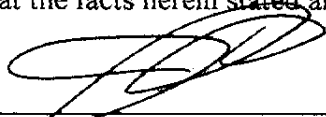

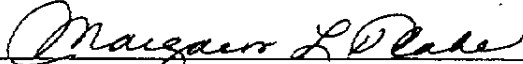
