The undersigned subscriber to these articles of incorporation, being a natural person and competent to contract, hereby forms a Corporation for profit under the laws of the State of Florida.

# ARTICLE L NAME

The name of this Corporation is Realty Pointe, Inc.

### ARTICLE IL PURPOSE
