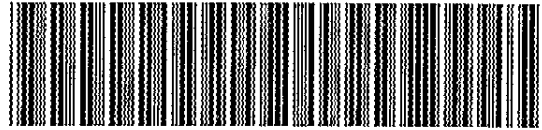

The Corporation shall indemnify any Officer, Director, Incorporator or any former Officer or Director, to the full extent permitted by law.

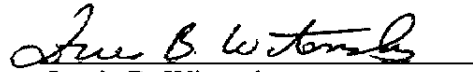
#### **ARTICLE XII - PREEMPTIVE RIGHTS**

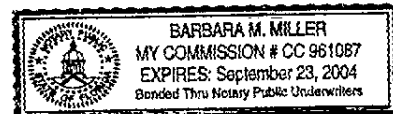
