ARTICLES OF INCORPORATION

The undersigned, acting as incorporator pursuant to Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation:

Article I.

NAME

The name of this corporation is Casa USA, Inc.

Article II.

ADDRESS

The street address of the principal office of the corporation is 1275 Bennett Drive, Suite 200, Longwood, Florida 32750, and the mailing address of the corporation is the same.

Article III.

CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of authorized stock all of one class at a par value of \$0.10 value per share, to be designated "common shares."

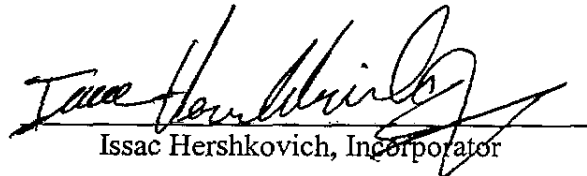
