

ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME

The name of this corporation is "FREV Company."

ARTICLE II

NATURE OF BUSINESS

AMENDMENTS



The date of execution is the July 16, 2003.

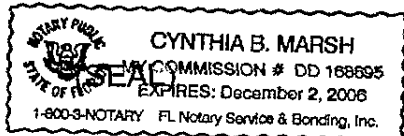
