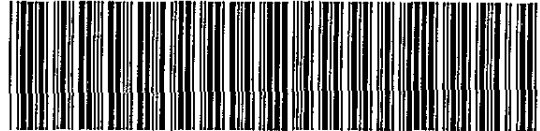


**ARTICLE VII:

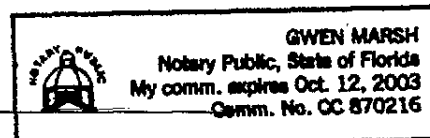
