CORPORATE NAME**



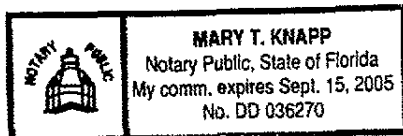
