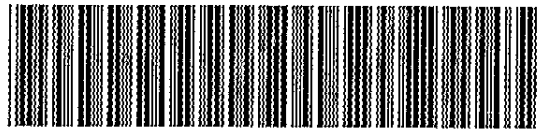

GCorp, Inc. is the name of this corporation.

**Article II:**

**LOCATION OF PRINCIPAL OFFICE**

**Article III:**

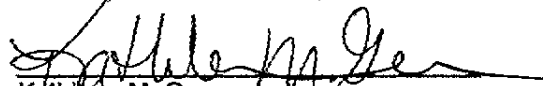
**Article XI:**

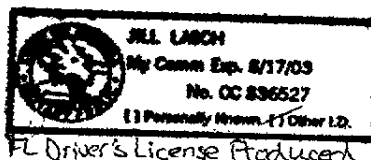
