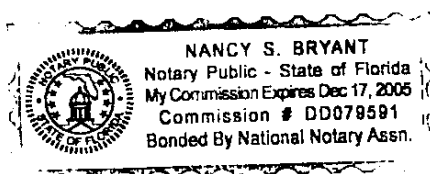
1. John Moyer is the President of M & M PROPERTY RENTALS, INC., a Florida corporation, (hereinafter "Corporation").
