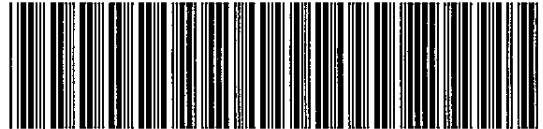

THE UNDERSIGNED acting as incorporators of a corporation
under the Florida General Corporation Act, adopt the following
Articles of Incorporation for such Corporation.

ARTICLE I. NAME.

The name of the corporation is

The specific purpose and nature of the business of


