**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF  
NEW HORIZONS REALTY INTERNATIONAL, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Article I - Name

The name of the corporation is NEW HORIZONS REALTY INTERNATIONAL, INC. (hereinafter referred to as the "Corporation").

Article II - Amendment

Article I of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

"The name of the corporation is WORLD PROPERTY CENTRE, INC."
