ARTICLES OF INCORPORATION

OF

MAXPLUS TRADING, CORP.

I, the undersigned, being of legal age and natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the state of Florida.

ARTICLE I
NAME

The name of this corporation is MAXPLUS TRADING, CORP.

PURPOSE
