Please find the completed document for reinstatement of MTD Innovations Inc.


I talked to a representative in your department a couple weeks ago. As I discussed with the rep. This is the first time I have maintained a Corporation in the State of Florida. I missed the deadline for filing the annual report. On or about the 6<sup>th</sup> of September I logged on the sunbiz website and put in the number on the notice card. According to the window that came up, the report had already been filed. I didn't file it, so I assumed that my accountant had. I did not follow up on it because in the next few weeks we were dealing with the two hurricanes that came through our area. Specifically I have two properties that sustained significant damage during the hurricanes.

At the end of October I received a notice of Dissolution. The card was delayed as we have had an address change. I was in the midst of a rehab on one of the properties owned by the corporation that was to have been on the market by mid September so the notice remained in a rather large pile of things to do while making the rehab the first priority. During that time, I did phone your office and the rep told me to write a letter explaining the circumstances and request an exemption to the reinstatement fee and be given permission to simply pay the annual fee of \$150.

I do hereby request that you consider doing this on our behalf. I did not request any funds for restoration of the properties from the State or from FEMA. I did not receive any assistance from insurance. I did the rehab on my own. That is the significant reason for the delay and missing the deadline. I just finished the rehab this week. Thankfully, the house sold within 24 hours and will close in 30 days.
