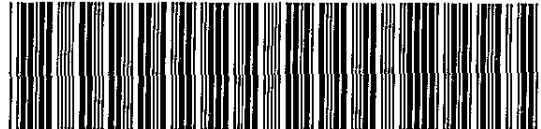

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is BAYSIDE PERSONNEL, INC., and the principal address and principal place of business is 470 2<sup>ND</sup> STREET NORTH, SAFETY HARBOR, FLORIDA 34695.

**ARTICLE II - REGISTERED OFFICE AND AGENT**

The address of its registered office in the State of Florida is O'CONNOR & ASSOCIATES, 2240 Belleair Road, Suite 160, in the City of Clearwater, County of Pinellas, Florida 33764. The name of its registered agent at such address is O'CONNOR & ASSOCIATES.

**ARTICLE III - PURPOSE**


