

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation:

These Articles of Amendment were adopted by the board of directors of said organization at a regular meeting with a quorum being present which was held on March 1, 2004. This board meeting met the requirements of both the Articles of Incorporation and the bylaws.
