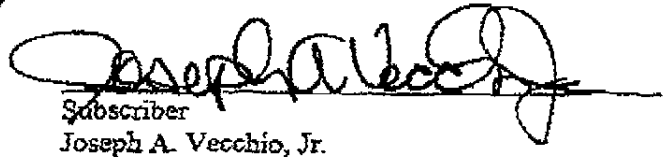
ARTICLE X - INDEMNIFICATION
