NAME

TERM OF CORPORATE EXISTENCE

AUTHORIZED SHARES

The aggregate number of shares which the corporation shall have authority to issue shall be Two Thousand (2,000) shares of voting common stock with \$1.00 par value per share.


ARTICLE IX

Expenses (including attorneys' fees) incurred in defending any claim action, suit or proceeding may be paid by the corporation in advance of the final disposition of such a proceeding.

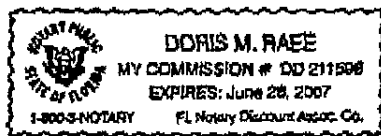


