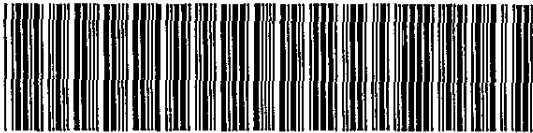

ARTICLES OF INCORPORATION
FOR
HYSCIENCE, INC.

FIRST: The undersigned

Eise T. Bingham	31140 Whitlock Dr. Wesley Chapel, Fl 33543

being at least eighteen years of age, does hereby form a corporation under the laws of the State of Florida.

ARTICLE I: The name of the corporation is: Hyscience, Inc.

The corporation shall be a close corporation.

ARTICLE II: The street address of the principal office of the corporation in Florida is: 31140 Whitlock Dr. located in the county of "County of Pasco."

ARTICLE III: The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the laws and statutes of the State of Florida.

ARTICLE IV: The corporation has authority to issue only one class of shares of stock. The corporation has authority to issue 2000 shares common stock at \$0.01 par value per share. All of the corporation's issued shares shall be held of record by not more than 30 persons.

ARTICLE V: The initial officer is Elise T. Bingham, who shall be the corporations President, Secretary, and Treasurer. The address of Elise T. Bingham is 31140 Whitlock Dr., Wesley Chapel, Fl 33543.

ARTICLE VI: The name of the registered agent of the corporation in Florida is: Elise T. Bingham whose street address is 31140 Whitlock Dr. Wesley Chapel, Fl 33543. The duration of the corporation is: Perpetual.

ARTICLE VII: The incorporator of Hyscience, Inc. is Elise T. Bingham, 31140 Whitlock Dr., Wesley Chapel, Fl 33543.

ARTICLE VIII: The duration of the corporation is perpetual.

ARTICLE IX: Indemnification of Officers, Directors, Employees and Agents: The corporation shall indemnify any person who incurs expenses or liabilities by reason of the fact he or she is or was an officer, director, employee or agent of the corporation or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise. This indemnification shall be mandatory in all circumstances in which indemnification is permitted by the laws or statutes of Florida.

ARTICLE X: Limitation of Liability: To the fullest extent permitted by the laws or statutes of Florida, as the same exists or may hereafter be amended, a director of the corporation shall not be liable to the corporation or its

stockholders for monetary damages for any action taken or any failure to take any action as a director. No repeal, amendment or modification of this article, whether direct or indirect, shall eliminate or reduce its effect with respect to any act or omission of a director of the corporation occurring prior to such repeal, amendment or modification.
