

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation:

## ARTICLE ONE

The name of the corporation is My Trading Company.

# ARTICLE TWO

The duration of the corporation is perpetual.

# ARTICLE THREE

The general purposes for which the corporation is organized are:

- 1. To own and operate import and export of general merchandise and distribute merchandise at wholesale and retail.
