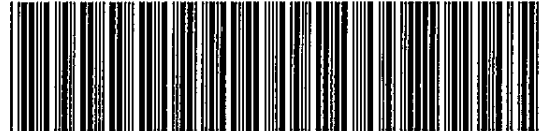

ARTICLE I - NAME

The name of this corporation is PATRICK CARMEN NR.9  
SALON, INC.

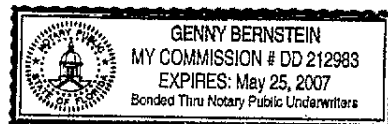

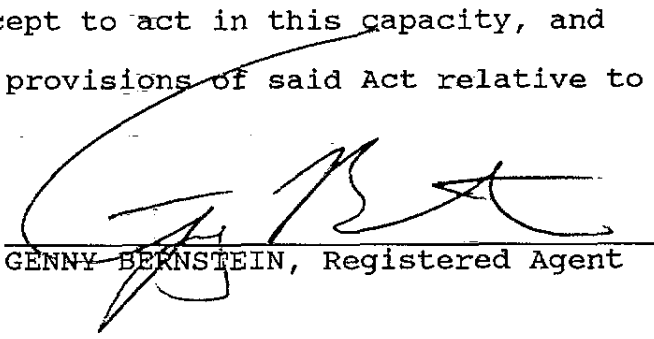

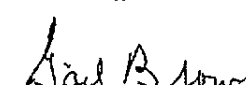
